Delivery and Return

Rates are quoted FOB Eagle Power and Equipment. Please contact us for a quote.

Eagle Power and Equipment Responsibility: To furnish a machine that has been properly maintained and in good running order.

Customer Responsibility:

1. Furnish a qualified operator.
2. Insure normal daily maintenance is performed, i.e. grease, oil levels, tire pressure, etc.
3. Inform Eagle Power and Equipment immediately of equipment failure or malfunction
4. Return the machine in clean condition or pay an additional charge of \$100 for equipment cleaning.
5. Accept liability for maintenance expense due to abnormal wear and/or damage to machine and tires

Fuel

Machine must be returned with a full tank of fuel or pay for fuel used

Insurance

Customer will be responsible for providing property and liability insurance coverage. Eagle Power and Equipment will charge 15% for physical damage insurance unless an insurance binder is provided in advance (\$2500 Deductible.)

Liability Insurance is the Responsibility of the Lessee:

Lessee at it's own expense shall carry adequate public Liability Insurance as approved by Lessor against bodily injury including death.
